Texas' nonprofit sector is continuing to grow, with over 134,000 organizations in 2022


Financial resources are not keeping pace with the sector's growth

Where are Nonprofits Located?







What Do Nonprofits Focus On?






This graph displays an overview of the growth distribution of nonprofits by focus areas.


Certain areas, such as Arts, Culture, and Humanities, exhibit relatively stable trends with minimal growth fluctuations.

Conversely, other focus areas, notably Human Services, demonstrate more pronounced increases in growth.

Contributions (for Public Charities only) have only increased by 4% (as of 2019)



Financial Health (Public Charities Only)






KEY FINDING

Nonprofits Keep Growing

Between the years of 2015 and 2022, the nonprofit sector grew by 22%.

The trend of more nonprofits being established each year continues, albeit now at a lessened pace.

KEY FINDING

Rural Nonprofit Challenges

As of 2022, 1 in 5 nonprofits in Texas are rural-based.

The greatest number of rural nonprofits are currently located in the west region of Texas.

For every dollar in revenue, the rural nonprofit sector receives **only nine cents**. While the rural nonprofit may have **more assets**, they receive **less incoming funding**.


